### City and Borough of Juneau Civil Fine Citation Appeal Form

Any person given notice of a civil fine citation by the City and Borough may appeal the citation by filing this form with the CBJ Citation Hearing Officer within thirty (30) days of the issuance of the citation.<sup>1</sup> If you appeal your citation, **the City and Borough must prove the citation to a hearing officer by clear and convincing evidence.**<sup>2</sup> You may be represented by counsel at your own expense during the course of this appeal.<sup>3</sup> **Unless you request an oral hearing on this form, you waive your right to an oral hearing.**<sup>4</sup>

**Signature Required on Back**

You **may request an oral hearing** before the hearing officer. At this oral hearing, you have the right to present personal testimony, present testimony from witnesses using subpoenas issued by the City, and present other evidence, as well as cross-examine the police officer who issued the violation.<sup>5</sup>

If you do not request an oral hearing, the hearing officer may determine your case based upon this written appeal form, your written statements, written statements of the issuing officer, and written statements of any witnesses.<sup>6</sup>

**CAUTION: IF YOU FAIL TO APPEAR AT YOUR ORAL HEARING YOU WAIVE ALL RIGHT TO A HEARING AND YOU WILL BE RESPONSIBLE FOR PAYING ALL FINES ASSOCIATED WITH THE VIOLATION.**<sup>7</sup>
